For the 2018-2019 tuition payments, we offer an *11 month (July – May) plan*. For an alternate tuition payment schedule, please call the School Office. Tuition and fees paid per student for a given year does not cover the cost to educate a child. Participation in the school’s fundraising programs helps offset the cost of education.

You will realize these benefits by using FACTS for your tuition payment plan:

1. **Payment Dates:** You may choose either the (*payment date(s) offered*) of each month as your payment date. Automatic payments can be made from a checking or savings account or from a variety of credit cards, if applicable.
2. **Convenience & Security:** Along with multiple payment plan options, your payments are processed securely through a bank to bank transaction.
3. **Consumer Account:** You may check your personal account or make payments online (if applicable) from the convenience of your home or office anytime.

PARISHIONER

The Finance Council of the parish has stated in order to qualify for the parishioner tuition rate, a family must:

- ❖ Be registered for at least one year and have an envelope number.
- ❖ Financially support the Church through regular weekly contributions.
- ❖ Demonstrate support for the mission of the Church by regular attendance at Mass and the Sacraments with their families and parish involvement.

Your status is reviewed at the end of each calendar year prior to the school's registration period to ensure compliance with the above mentioned conditions. Failure to comply may result in a change of tuition rate. Exception to this policy will be considered after meeting with you personally to discuss your involvement in the parish and your individual circumstances.

TUITION INCENTIVE

Any family who recommends our school to a new registrant* for grades K-8 will receive a \$100.00 credit towards their tuition, per registrant. If you refer a family that registers three (3) children, you would receive a credit of \$300.00.

*New registrant(s) must complete and pay the tuition for one full school year to receive this credit. The credit will be applied in the following school year. If it is your last year at Saint James, the credit will be applied to your last tuition payment.
